- The Chishankhugadhi Rural Municipality, Office of Rural Municipal Executive has allocated funds towards the cost of "Construction of Main Administrative Building of Chishankhugadhi Rural Municipality" and intends to apply part of the funds to cover eligible payments under the Contract for CRM/CMAB/NCB/08/077/78. Bidding is open to all eligible as per Section V of bidding document.
- 2. Chishankhugadhi Rural Municipality, Office of Rural Municipal Executive invites electronic bids from eligible bidders for the "Construction of Main Administrative Building of Chishankhugadhi Rural Municipality" under National Competitive Bidding-Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs.7,33,00,000.00
- Minimum Work experience of similar size and nature: [1(one) (Government, Semi-Government, Corporate, Sangh-sanstha, Corporation, Institutional Building Construction Projects) contracts within the last ten (10) years with a value of at least NRS 7,82,00,000.00(Excluding VAT) that have been successfully or are substantially completed]
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in one envelope as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents visiting PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

- Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before [12:00 hours] on [2078/04/05 BS]. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at [13:00 hours on 2078/04/05 BS] at the office of [Chishankhugadhi Rural Municipality]. Bids must be valid for a period of [90 days] after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of [NRs.31,00,000.00], which shall be valid for 30 days beyond the validity period of the bid.
